- **Marketing Report**: Mark Stevens:
- 3gun nation went live with their registration tonight 11-14-16
- Many good things happening at FLSC for 2017. The attention to the club in 2017 is amazing.
- Site in days, up to 127% increase over last year with fewer open days.
- Total in 2016 of \$24,668.00 compared to \$29,483.00
- Revenue per day 2016 was \$1,174.67 VS 2015 at \$921.34
- Days open: 2016 was 21 compared to 2015 at 32 days
- He didn't feel the expensive ad in Outdoor News didn't do much for the marketing and numbers for FLSC
- Web traffic was up 178%, Facebook likes were up 124%, we gained several email address up 543 from last year (each email is worth approximately \$5.00) as well from the on line media campaign

- Figured out a solution to upload documents
- Will be doing a revamping of the members website to correct some of the problems people have been experiencing
- Heated 5 stand marketing, approximate start date January 14/15 2017. Looking for a small budget of \$200-\$300.00 for these events. No vote or discussion on this budget. Will talk about it at a later date
- Captains meetings for trap teams usually in March. Looking at starting recruitment earlier than what we did last year, perhaps in January or February

-Managers Report: Ron W.

- Sight in days recap for 2016: Total revenue \$24,668.50, open for 21 days, Average per day: \$1,174.69, Total Man days: 229, Paid Tara and Lexi 5 days, Lunches came to \$1,443.82
- Volunteering was still scarce. Sometimes not knowing if there would be enough people until the night before or the morning of the day
- Ron stated we need at least 2 people per shoot house to be safe, even more when it is a busy day
- The eyebrows are all pre-drilled, cameras haven't been installed yet on the ranges. Prototypes for shoot house benches have not been completed. These projects are all member driven volunteer projects
- <u>New member orientation:</u> Don was gone hunting, but he is now back and helping new members once again. Discussion on how long Don will be doing the orientation.
- Membership expansion: currently we have 75 people on the wait list.
- Motion made by Steven, 2nd by Al to increase the membership by 100 people, up to 700 members for FLSC
