Operations report: Ron Westberg-

- 21 days open in 2017 (same number of days as 2016) Revenue in 2017 \$25,113.50 vs \$24,954.00 in 2016 After all expenses paid for 2017, FLSC saw a total net profit of \$9.839.74
- October saw heavy law enforcement training sessions
- FLSC hosted a sporting clays event for Federal Cartridge on October 12th. Eleven shareholder volunteers to help run the event. Federal had 47 employees attend with a catered lunch
- The bill for the barn roof repair at gate 3 was bid at \$2,440.00 originally, but the final bill was \$2,106.00 which saved FLSC \$334.00
- Snow blower discussion, motion was already approved for up to \$1,000.00. A Toro snow blower was identified for approximately \$800.00

- Would like to buy a battery powered impact wrench to help with repairing of tires etc. on 5-stand. A Rigid brand impact wrench was found for \$238.00 plus tax.
- Motion by Ben, 2nd by Tony to approve the purchase up to \$300.00 for a battery powered impact wrench. Motion carried 7-0 at 1915hrs
- H-vac system heat wasn't working at the gate #3 club house. Discussion on maintenance of the systems. Gate #3 needed new filters and a belt. Plenty of sand going around which effects the systems
- Gary said a number of the trap kids are leaving for higher paying jobs. This might be a problem for next summer. Many places pay at least \$10.00/hr. Something to consider.

Marketing report: Mark Stevens

- Site in Budget this year slightly higher than what he wanted to see, although it was \$1,300.00 cheaper than it was in 2016
